So, the Next Day, When King (Herod) Agrippa (II) and (Queen) Bernice Had Come with 'Great Pomp', and had entered the Auditorium with the Commanders and the Prominent Men of the City (Caesarea Maritima), at (Governor) Festus' Command Paul was Brought In. And Festus said: "King Agrippa and All the Men Who Are Here Present with Us, You See This Man (Paul) About Whom the Whole Assembly of the Jews (Sanhedrin Council) <u>Petitioned</u> Me, both at Jerusalem and Here (Caesarea Maritima), <u>Crying Out</u> 'That He Was Not Fit to Live Any Longer' But When I (Festus) Found that He <u>Had Committed Nothing Deserving of Death</u>, and that He Himself Had Appealed to (Caeser) 'Augustus', I <u>Decided To Send Him</u> (to Rome). (However), I <u>Have Nothing Certain To Write</u> to 'My Lord' <u>Concerning Him</u>. Therefore, I (Festus) Have Brought Him Out Before You (All), and Especially Before You, King Agrippa, So that After the <u>Examination</u> Has Taken Place, I <u>May</u> <u>Have Something to Write</u> to (Caesar). For It Seems to Me Unreasonable <u>To Send</u> a Prisoner and <u>Not to Specify the Charges Against Him</u>."

- 4) Power Almost Unlimited Save The Roman Caesar Above Them
- 5) Prestige Everyone Gives You Their Allegiance & Cooperation As They Need Your Approval
- 6) Prosperity Their Wealth & Decadence Gives Them The Right To Flaunt Themselves & Their Lifestyle. They Demand The Approval of Those Less Affluent & Under Their Patronage or Rule, Despite Their Disgust, Evil, & Irreverent Behavior

 Festus Recaps The Main Point of Contention of Recent Trial of Paul For The Esteemed Audience

 And Festus said: "King Agrippa and All the Men Who Are Here Present with Us, You See This Man

 (Paul) About Whom the Whole Assembly of the Jews (Sanhedrin Council) Petitioned Me,

 both at Jerusalem and Here (Caesarea Maritima), Crying Out
 'That He Was Not Fit to Live Any

 Longer'''

Festus Recaps The Main Findings of Paul's Recent Trial

"But When I (Festus) Found that He <u>Had Committed Nothing Deserving of Death</u>, and that He Himself Had Appealed to (Caeser) 'Augustus', I <u>Decided To Send</u> Him (to Rome)." Acts 25:25

**Festus** States The <u>Reason He Has Invited</u> All of Them Together <u>To Hear</u> Paul Themselves "(However), I (Festus) <u>Have Nothing Certain To Write</u> to 'My Lord' <u>Concerning</u> Him. Therefore, I Have Brought Him Out Before You (All), and Especially Before You, King Agrippa, So that After the <u>Examination</u> Has Taken Place, I <u>May Have Something to Write</u> to (Caesar)." Acts 25:26

Central Question

"What Was Festus Hoping Would Happen After All His Distinguished Guests Heard Paul Themselves?"

1<sup>st</sup> Central Answer

They Would Give Him Something Important & Legal Sounding To Send As A Formal Allegation

To Accompany the Roman Delegation of Soldiers to Rome With Paul As Their Prisoner.

2<sup>nd</sup> Central Answer

They, Especially King Agrippa II, Would Take Paul's Arrest & Future Into His (Their) Own Hands, And <u>Alleviate Any Responsibility</u> From Festus As Governor.

Therefore, He Could Legally Rescind Paul's Appeal To Caesar Himself.

Finally, Festus Discloses His Anxiety Over Sending Paul To Rome

"For It Seems to Me Unreasonable <u>To Send</u> a Prisoner

And Not to Specify the Charges Against Him."

Acts 25:27
